

General Rules for Admission:

- 1. Prospectus & Admission form is available from 1st day of January & July of every year in college campus.
- 2. It is compulsory for all students to mention all information truly and to affix latest photograph.
- 3. All students must submit transfer certificate, declaration and required fee within 5 days of the declaration of the merit list of admission.
- 4. Those candidates who come from Universities other than CCS University, Meerut must submit migration certificate within 15 days of admission.
- 5. Every document attached with admission form must be self attested.
- 6. The college reserves the right to cancel the admission at any time if any information provided by the student is found to be incorrect & misleading.
- 7. The student must give declaration that he/she has not been found guelty of using unfair means in the University/ Board examination and never been convicted in any case under I.P.C.
- 8. The student shall also give undertaking that he/she will not be engaged in any type of ragging and unlawful activities is the college campus as well as outside the campus otherwise he/she will be personally liable for penalty or punishment including FIR and cancellation of admission from the college.
- 9. All registration / Admission are provisional subject to confirmation by the university. A mere filling up of this form does not give any right of admission.
- 10. The college has a right to cancel the admission of student it he is found involved in disobeying the rules of the college.
- 11. All deposits, fee shall be non-refundable. If any student leaves the college in mid-session by any reasons, he will have to deposit all fees of full session, library card & identity card.
- 12. All students must come to college in uniform.
- 13.75% attendance is compulsory for all students otherwise he/she shall be debarred from examination.
