

Teaching Methods in Legal Education:

There are various kinds of Teaching Methods in Legal Education an across the global level. An out of which more specific and prominent methods are as follows:

- 1. Lecture Method
- 2. Case Method
- 3. Problem Method
- 4. Discussion Method
- 5. Simulation and Role Play
- 6. Collaborative Teaching Method
- 7. Seminar Method
- 8. Clinical Method
- 9. Other method



Advantages of lecturing method

- Lecture is a passive method of teaching. Lectures are used to convey critical information, history, background, theories and equations.
- Facilitating large-class communication. Large numbers of students get the benefit of gaining information, . Greater teacher control in the classroom,
- 3. An engaging format, which may complement and clarify course material,
- 4. Students listening skills develop
- 5. Help to learn languages and
- 6. Lecturing also permits the dissemination of unpublished or not readily available material.



Disadvantages of lecturing method:

- Placing students in a passive (rather than an active) role.
- 2. Grabbing attention of students is very difficult.
- Slow learners face problem in following teaching/ lecturing.
- Encouraging one-way communication. The lecturer gives lecture and the students listen but don't interact.
- 5. Requiring significant out-of-class time for students to engage with the material, and
- 6. Lecture methods are constrained to class room teaching only.
- 7. Requiring the speaker to possess effective speaking skills.

Types of lecture method:

- Oral also includes face to face lecturing method and online lecturing method.
 Traditional
- Textual/ multimedia includes PPT, CD's lecture3. Participatory lecture includes debate / group discussions.
- Problem solving. A problem becomes the focus for demonstration and generates various solutions.

The above methods from 1 to 3 come under the category of old traditional method of teaching. Lecture method should be used and is most effective when it presents information which students cannot learn on their own.

Steps to be followed in order to deliver good lecture while applying lecture method:

- 1. Know your audience (students, officials, laymen, professionals, workers, housewives. etc.)
- 2. Prepare a map to follow (lecture outline)
- 3. Start the lecture with an introductory topic (grab attention of the audience)
- 4. Recognize audience attention span
- 5. Plan an activity for the audience/ students
- 6. Use attractive way of presentation by way of audio and visual presentation tools
- 7. Have a conclusion, summary at the end of lecture and
- 8. Give assignments/ task for the audience/ students to prepare and come based on the lecture delivered.





Purpose of Visit: The purpose of the visit was to understand the working of a court, the nature of duties of the judicial officers. The visit was to help the student in understanding the role of court in dispensing justice in any case, the role of prosecutors in a case, the way cases proceed in a court, the way judges, prosecutors and defense lawyers handle the case, the relationship of the prosecutors and the police. This gave an opportunity to understand the actual need of co-ordination in the justice system. The visit included an in-depth study of the day to day functioning of the Civil and Criminal Courts, at different levels and over a vast variety of cases. 
