About Consumer Advocacy: Industrialization has brought many revolutionary changes in the national economy and extended benefits to the society at large. Major contribution in providing economic benefits to individual can be given to the industrialization. But, this industrialization has negatively impacted upon the consumer's interest. To address consumer related issues and create awareness about the consumer's right in the society; This seminar is an attempt to fulfil the objectives of the college.

About the Seminar: Due to significant development of industrialization, consumers were exploited to large extent. With certain objectives such as to avoid exploitation of consumers, recognition of consumer's right and remedies against the unfair and restrictive trade practices, the Consumer Protection Act, 1986 was passed.
