A one day workshop was conducted on "Arbitration, meditation, conciliation and ADR" by SVM Law college Shikarpur on 20<sup>th</sup> September 2021 respectively. Assistant Prof. Mrs. Sweta Singh HOD of SVM Law college and Research and Publication Committee organized a workshop on "Arbitration, meditation, conciliation and ADR' in seminar Hall. Workshop have a two session. First session conduct by Resource person - Ms. Vidhyanjali Singh H.O.D. / Assistant professor of CERT Meerut and second session conduct by Mrs. Sweta Singh Assistant professor SVM Law College,



Speaker- Ms Vidhyanjali Singh Firstly, the workshop addressed the concept of Alternative Dispute Resolution and examined its merits as a viable surrogate to the traditional dispute resolution route Through Courts of Law. The participants were guided through the processes of Negotiation, Mediation, Conciliation and Arbitration, wherein the processes were defined and their legal import expounded upon, following which, the various stakeholders in each of the processes were demystified. These processes were distinguished from one another from a practical paradigm. Hereafter, the process of Mediation was discussed in depth. The panel drew the attention of the participants to the structure of

a mediation session. The role of the Mediator was elucidated and distinguished from the role of an Arbitrator, a conciliator and a Judge. Participants were called upon to notice various techniques employed by Professional Mediators to bring parties to an amicable agreement. Following the discussion on Mediation, the focus was shifted to the process of Negotiation. The panel enlightened the participants on the benefits of the negotiation process in enabling swift, innovative and comprehensive resolutions to contentious matters without requiring the intervention of third parties.

Various negotiation principles such as Needs, Interests, Wants and Motivation were understood and thereafter, scrutinized from a practical perspective, wherein the panel harnessed their combined experience to enable the participants to arrive at a lucid understanding of their relevance to a negotiation.



Second speaker Mrs Sweta Singh ,speak about Negotiation Styles were identified as Aggressive, Collaborative, Avoiding, Compromising and Accommodating and thereafter, the participants were called upon to identify their most preferred negotiation styles. Activities were conducted to enable the participants to appraise each style of negotiation. Additionally, the panel advised the participants on the practical import and consequences of each style, and techniques to navigate through the negotiation while employing these styles. A few test situations were identified and these concepts were applied to understand how these indicators enrich the negotiation process and sculpt the outcome of the negotiation process. Additionally, the panel also undertook to explain the process of arriving at these negotiation indicators through examples from real-world situations. The fitness and



MEANING OF MOOT COURT

Moot Court is an artificial Court which is especially made for the lawful students to have the practical knowledge of drafting, pleading and conveyancing. In the moot court an artificial problem was given to the students for which they have to prepare their arguments and present it before an expert.

According to chambers 20th century dictionary the term moot means to discuss or to argue for practice. Generally the moot courts are organized in law colleges, universities. The student participated in the moot court called as mooters.



### DIFFERENCE BETWEEN MOOT COURT AND REAL COURT.

A moot court is and artificial court prepares for the law students whereas a court is always establish by an act and it is judicial process. In a moot court the students have to argue on the law point only whereas in a real court the filings, arguments are done as per the law and procedural rules.

In a court the Judgement is finally delivered on the basis of facts and circumstances. Whereas in moot court only arguments are held and no judgement will be delivered. In a real court if there is a
