A one day workshop was conducted on "Arbitration, meditation, conciliation and ADR" by SVM Law college Shikarpur on 20<sup>th</sup> September 2021 respectively. Assistant Prof. Mrs. Sweta Singh HOD of SVM Law college and Research and Publication Committee organized a workshop on "Arbitration, meditation, conciliation and ADR' in seminar Hall. Workshop have a two session. First session conduct by Resource person - Ms. Vidhyanjali Singh H.O.D. / Assistant professor of CERT Meerut and second session conduct by Mrs. Sweta Singh Assistant professor SVM Law College,



Speaker- Ms Vidhyanjali Singh Firstly, the workshop addressed the concept of Alternative Dispute Resolution and examined its merits as a viable surrogate to the traditional dispute resolution route Through Courts of Law. The participants were guided through the processes of Negotiation, Mediation, Conciliation and Arbitration, wherein the processes were defined and their legal import expounded upon, following which, the various stakeholders in each of the processes were demystified. These processes were distinguished from one another from a practical paradigm. Hereafter, the process of Mediation was discussed in depth. The panel drew the attention of the participants to the structure of

a mediation session. The role of the Mediator was elucidated and distinguished from the role of an Arbitrator, a conciliator and a Judge. Participants were called upon to notice various techniques employed by Professional Mediators to bring parties to an amicable agreement. Following the discussion on Mediation, the focus was shifted to the process of Negotiation. The panel enlightened the participants on the benefits of the negotiation process in enabling swift, innovative and comprehensive resolutions to contentious matters without requiring the intervention of third parties.

Various negotiation principles such as Needs, Interests, Wants and Motivation were understood and thereafter, scrutinized from a practical perspective, wherein the panel harnessed their combined experience to enable the participants to arrive at a lucid understanding of their relevance to a negotiation.



Second speaker Mrs Sweta Singh ,speak about Negotiation Styles were identified as Aggressive, Collaborative, Avoiding, Compromising and Accommodating and thereafter, the participants were called upon to identify their most preferred negotiation styles. Activities were conducted to enable the participants to appraise each style of negotiation. Additionally, the panel advised the participants on the practical import and consequences of each style, and techniques to navigate through the negotiation while employing these styles. A few test situations were identified and these concepts were applied to understand how these indicators enrich the negotiation process and sculpt the outcome of the negotiation process. Additionally, the panel also undertook to explain the process of arriving at these negotiation indicators through examples from real-world situations. The fitness and

- 2-Preparing any legal document, such as a legal letter or court motion.
- 3-Getting involved in a legal transaction, which can include legal documents but also negotiation, representation of clients, and more.

#### Objective of course

Legal drafting is important because the process helps to make sure that legal documents are formatted correctly, that all parties who are involved in the document are happy with the details of it, that jargon is explained, and that everything you'll be presenting to the court or another presiding body is laid out as it should be. A legal document should explain its purpose, be amenable to all parties, and be drafted in such a way that it's legally binding and acceptable in the eyes of a court.

An error in a legal draft, however small, can severely affect the meaning of that document and have long-term consequences, especially if it's a legal document that is signed and executed and that all parties must abide by moving forward. A well-constructed document can make a big difference by helping an attorney win cases in court or preventing lengthy mediations in the workplace over an employment contract dispute.
